# **PARTNERING & FUNDING**

- At Futures, our partnership with Travis Perkins has enabled us to access social value focused funding for placemaking activities such as wildflower and tree planting across some of our estates.
- Orbit is exploring partnerships with local Wildlife Trusts and supplier social value contributions. Together they are also working to deliver a campaign that encourages customers to increase the wildlife and nature in their private outdoor spaces.
- At <u>Ground Control</u>'s Wildfell Centre for Environmental Recovery, they are demonstrating the value of partnership 'Super Groups', working with Essex County Council, Essex Wildlife trust, RSPB, Bumblebee Conservation Trust, Plantlife, Dragonfly Trust, Farming & Wildlife Action Group East, Environment Agency, Royal Botanic Gardens Kew, The Forestry Commission, The Big Green Internet, CSX Carbon, and Briggs Equipment. The plan for the 296-acre site in North Essex includes the planting of hedgerows, native trees and wildflower meadows, the creation of ponds, and landscapes to benefit walkers, forest schools and community groups.
- Trumpington Meadows in Cambridge is an award-winning development, in partnership with Barratt Homes, BPHA and the BCN Wildlife Trust. The new development includes 40% social housing, and access to a 58-hectare country park and nature reserve.
- Sovereign Housing Association joined Friends of the Earth Newbury and Ground Control to plant 200 saplings in a 'Lockdown Wood' in the heart of Newbury. The tree-planting project started in response to West Berkshire Council's draft Environment Strategy.
- Kidbrooke Village is a new housing development in London that will provide more than 4,800 homes and 35 hectares of varied, semi-natural open space. It's the result of a partnership between London Wildlife Trust and Berkeley Homes. The centre of the site is Kidbrooke Park, which will be designed to be a green corridor for people and wildlife.
- The Southall Grand Union Canal Wellbeing Way is a project developed by Peabody, the Canal & River Trust, Ealing Council and Sport England. The Lottery funded projects is transforming the canal towpaths and surrounding green spaces in Southall to boost wellbeing, biodiversity and climate resilience.
- Good Parks for London have a full resource hub for green space management and their Good Parks for London 2022 Report highlights lots of successful green space case studies across the city.
